Position: Catchment Coordinator – Motueka Catchment Collective

Reports to: Trust Manager – Tasman Environmental Trust Takes guidance from: Motueka Catchment Collective Steering Group

Term and FTE: Fixed term to October 2025, 37.5hrs/wk – job-share or part time positions will be

considered.

The Motueka Catchment Collective (MCC) is appointing a Catchment Coordinator to work with landowners, sub-catchment groups, and thematic working groups to promote the well-being of the freshwater system and connected environment.

Under the guidance and direction of the Motueka Catchment Collective Steering Group (MCCSG) the coordinator will build engagement and interaction with farmers, foresters, landowners, iwi, Council, industry stakeholders and others with an interest in the catchment's health. They will build on the extensive integrated catchment management work conducted previously in the catchment and support the emphasis of Te Mana o te Wai that puts the health and well-being of the freshwater ecosystem as priority.

For the right, talented professional, this job offers a good mix of autonomy, freedom and negotiated accountability, job flexibility without the burden of excessive bureaucracy. If you really want to work with willing landowners and want to create a lasting legacy by improving an iconic river, this is your job.

This role is independent from and additional to District Council appointed catchment facilitators.

## **Key Tasks**

- Work with the Motueka Catchment Collective Steering Group to oversee the smooth running of a large catchment project, including establishing good communication between the various parties, and keeping oversight of actions, milestones, and reporting required by funding agreements.
- Support landowner capability building and knowledge and provide advice to improve water quality on their farms.
- Support farmers with the uptake of freshwater farm plans by working with farm industry groups and support organisations.
- Work with members of the Motueka Catchment community to establish sub-catchment groups and identify key community actions for different areas.
- Work with the Steering Group, the wider community, and relevant stakeholders to establish thematic working groups and projects for the topics of freshwater monitoring, forestry, biodiversity restoration, river management, weed & pest management, and river access & recreation.
- Support discussions with key stakeholder and potential partners including iwi, Council, DOC, industry sectors, agencies, and organisations and researchers with initiatives and interest in the catchment, to strengthen relationships for the ongoing work of MCC.
- Work with the Steering Group, sub-catchments, and thematic groups to develop an integrated catchment management plan.
- Help identify and write additional funding applications that meet the MCC goals
